Constitution

ARTICLE I Name and Purposes

The **Salt Lake Crossroads Amateur Radio Club** (hereafter known as "the Club") is hereby formed to promote the enjoyment of the hobby of amateur radio and to support emergency and disaster communications within communities of and around Salt Lake City, Utah.

ARTICLE II Membership

All persons interested in amateur radio communications shall be eligible for consideration as members of the Club. Membership shall be by application and approval or election upon such terms as the Club shall provide in the By-Laws. Membership may not be denied due to race, creed, color, religion, gender, sexual orientation, political affiliation, marital status or any other reason that would be biased or prejudicial. Membership may be revoked for cause as provided in the By-Laws.

ARTICLE III Officers

The affairs of the Club shall be managed by the Officers elected by the membership as outlined in the By-Laws. The Officers of the Club shall be President, Vice President, Secretary and Treasurer or Secretary/Treasurer.

ARTICLE IV Trustee

A member of the Club licensed as an amateur radio operator shall be identified as the Club License Trustee. The Trustee shall establish and maintain an Amateur Radio Club Station for the use of the licensed members of the Club and other licensed radio amateur operators for the Purposes of the Club. The Trustee shall carry out the duties designated by the Federal Communications Commission (FCC) for the trusteeship of the station. Selection of and replacement of the Trustee shall occur as provided in the By-Laws.

ARTICLE V Dues, Fees, and Donations

Membership dues, fees or other assessments deemed necessary for the business of the Club shall be determined annually by a vote of the membership as provided in the By-Laws. Donations may be accepted as provided in the By-Laws.

ARTICLE VI Meetings

The Officers shall determine the date and place of meetings of the general membership of the Club and of meetings of the Officers. Notice of meetings shall be given under direction of the President by the Secretary as provided in the By-Laws.

ARTICLE VII Alterations, Amendments, Repeals

The Constitution or By-Laws may be altered, amended or repealed by a two-thirds (2/3) vote of Club members as provided in the By-Laws.

ARTICLE VIII Dissolution

The Club may be dissolved by the vote of responding Club members as outlined in the By-Laws.

Disposition of assets shall be handled by the Officers or by committee assignment. No member or group of members shall receive benefit from the assets. All equipment will be sold and net proceeds donated to one or more non-profit organizations. All remaining cash will be donated to one or more non-profit organizations.

Dissolution shall be effective when all the affairs of the Club have been concluded satisfactorily, as determined by the Officers of the Club.
